## **NCRF Fall Quarterly Meeting**

## **October Meeting Recap**

NCRF President, Matt Johnson, welcomed a full house of members and made a few announcements. Matt reminded attendees that the Winter Quarterly meeting in January 2014 will be free with a philanthropic event. The highlight of the meeting will be a roundtable on Total Rewards professionals. In fall of 2014 there will be a PNW Joint Conference to be held in Portland, Oregon in partnership with CWCG. It will be a 1-day, dual track conference with a key note speaker. Matt thanked the current Board members for their hard work this year and recognized those Board members whose term of office expires at the end of 2013. NCRF Training Director-at-Large, Windsor Lewis, announced the regional training schedule for 2014.

Programs/Sponsorship Director, Jay Bulson, introduced the guest speaker, Melaine Sprague, CCP, GRP. Her presentation was "Aligning Total Reward and Global Business Strategy". She opened the presentation with her favorite quote "Strategy without tactics is the slowest route to victory. Tactics without strategy is the noise before the defeat." from Sun Tzu. It reminds us that strategy is not rocket science. It is about asking tough business questions and effective project planning.

Melanie used a consulting case study to illustrate this principle. She was hired as a consultant to address turnover issues at a midsized company. She started by asking and finding the answer to many questions such as:

Do you need more sales staff? Do you need more training for staff? Why are employees leaving? What can the company afford? Who is critical in respect to organizational development? Where does staff need to be organizationally? Are there changes already planned and how will that effect outcomes? Who will the Executive sponsor be? Will change yield quick or long term results? What is valued by employees? Who do we want to keep? Who do we need to keep? What problems will that invoke?

By applying project planning skills she developed a plan and timeline, assembled a confidential project team, developed a communications plan and was very patient while executing the plan. Of course there were challenges; management resistance, desire to over engineer and get lost in the details, insufficient communications, and insufficient data are a few. In addition to effective project management skills Melanie stressed the need for executive sponsorship.

Melanie was warmly thanked with a big round of applause.

Jay closed the meeting by announcing he would send an e-copy of the presentation to attendees.
