2016 Scholarship Application

The Northwest Compensation and Rewards Forum (NCRF) offers a Scholarship Program to support the educational efforts of its members by providing financial assistance for WorldatWork certification courses.

Each year, the NCRF Scholarship Program will award scholarships to individuals who are pursuing at least one WorldatWork certification designation. The amount of the scholarship is the lesser of \$1,350 or the cost of one NCRF (Seattle) or CWCG (Portland) WorldatWork course (at the then current NCRF discounted rate). Scholarship recipients will have two (2) years from the grant of the scholarship award in which to utilize these funds. The Application can be found on the NCRF website under the Training section.
